The New Stuyahok Traditional Council, individual (s) returning from Anchorage, out of State including other villages where there is a positive outcome must self-quarantine for 14 days upon arrival.

NOTE: The 14 day quarantine is mandatory for any individual(s) that is traveling to New Stuyahok including the family members of the individual(s) that returned from places that tested positive cannot enter any establishments, businesses, no mingling with other people, no visitations to other homes during the 14 day quarantine, it takes up to 14 days or more for the virus to test positive, this is the specific reason for the 14 day quarantine.

ALL IT TAKES IS ONE INDIVIDUAL TO SPREAD THE VIRUS SO PLEASE FOR THE HEALTH AND SAFETY OF OUR COMMUNITY FOLLOW THE MANDATES BEING POSTED.

PUBLIC NOTICE

TRAVEL NOTICE: Individuals traveling into our village from Anchorage, out of state, other villages where there is a positive need to quarantine for 14 days,

MANDATORY: 14 day quarantine includes the 4 tests as required, 1st test will be on the next day of arrival to the village, the 2nd test will be 3 days following the 1st test, a 3rd test will be 3 days following the 2nd test and the final test will be on the 14th day.

PUBLIC GATHERING: There will be no large public gathering in public buildings, homes and outside of homes or entities, wear masks at all times when social gathering this includes 6 feet social distancing.

The New Stuyahok Traditional Council is hiring 4 COVID19 Enforcement Officers to make sure that all mandates are being followed by all members of the community and visitors, the City of New Stuyahok VPOs will be out patrolling for individuals that should be quarantining and whom are not following the mandates, since individuals continue not to follow the required mandates the New Stuyahok Traditional Council is imposing a fine of \$175.00.
