

Seafood Trade Relief Program (STRP) Quick Reference Guide

Purpose	Eligibility
Relief program for producers while the federal administration works on trade deals. Funds are not COVID-19 related. Payment is limited to \$250,000 per individual or legal entity.	Commercial fishers who had a permit and sold fish to a legally permitted or licensed seafood dealer in 2019 and 2020. Adjusted Gross Income cannot exceed \$900,000 unless at least 75% is from fishing.
