

Clarks Point Village Council
COVID-19 Travel Mandate
Amended 3/12/2021

At a special meeting on 3/12/2021, the Clarks Point Village Council unanimously passed a motion to amend the travel/quarantine mandate. This 3/12/2021 mandate supersedes and replaces all past travel mandates/policies. ***This mandate continues to apply to all regardless of vaccination status.** The primary changes include: **Allowing residents to travel out of region for non-medical purposes with the 14-day quarantine still in effect after travel is completed.**

At a special meeting on 3/12/2021, the City of Clarks Point unanimously passed a motion to support the CLPVC Mandate as issued 3/12/2021.

Non-Residents

Clarks Point is still on lockdown to non-residents. Non-Resident must get permission from the Clarks Point Village Council prior to coming to Clarks Point. Travel may be approved in situations where it is deemed necessary and is considered low risk to the community. If approved, they must comply with all social distancing and quarantine measures.

Residents of Clarks Point

- May complete day travel trips within the Bristol Bay Region if needed without approval and without having to quarantine upon return.
- May complete overnight travel trips within the Bristol Bay Region if needed without approval but must quarantine for 7 days upon return (household members must also quarantine).
- May complete travel trips for outside of the Bristol Bay Region for but must still quarantine for 14 days upon return (household members must also quarantine).

During travel, please wear a mask, utilize hand sanitizer/gloves, and limit trips to necessary tasks to limit exposure.

Essential Workers

May enter Clarks Point if needed for necessary services are not required to quarantine if travelling to Clarks Point to provide essential services but are strongly encouraged to limit close contact with community members as much as possible. Essential workers include but are not limited to law enforcement, medical staff, school staff, maintenance workers, and other necessary fields entering the community for work purposes.

All

- Must comply with all State mandates in addition to local mandates.
- Contact the Health Aide or BBAHC if you or anyone in your household is exhibiting any symptoms that may be consistent with COVID-19.

Strongly recommended to:

- Wear a mask when within 6 feet of someone not part of your household.
- Limit travel as much as possible.
- Limit interactions with those outside of your household in an indoor setting.
- Not gather with those outside of your household, especially in an indoor setting.

Quarantine

- If you are under quarantine per State of Local mandate, during the time span of the quarantine:
- Those who are in your household or that you stay with will be under quarantine as well.
- Do not enter the home of anyone outside of your household or allow anyone in or they will be under quarantine as well.
- **Do not enter any business/entity building.**
- May be outdoors but should stay at least 6 feet from others not in your household.

Those who do not comply with the travel/quarantine mandate may be subject to a fine or loss of services. If you have concerns regarding breaches in quarantine or other safety hazards, contact a CLPVC Council Member directly.

Violation process: Step #1: Warning, Step: #2 \$500 fine, Step #3: \$1000 fine + loss of CLPVC provided services for 1 year (additional grant provided benefits, access to future assistance programs offered through CLPVC...etc.).
